LESSONS – SUMMER 2023

The summer riding lessons are divided into two sessions of five weeks each. Lessons take place in the cool of the early morning and evening.

PLEASE ! REGISTER BY JUNE 8

As the schedule changes each session, students must register each session. We schedule registrations as they are received. Register early to help insure your time choice. Forms with payment should be in the office by June 11. Late registrations will be scheduled if there is a space available in a suitable class. The staff tries to schedule each student for the first choice of time requested. Please list a second choice in case your first choice is not available. Riders will be called after June 11 to verify lesson times.

Session tuition is based on weekly hour group lessons:

First summer session:

\$375 - - paid in full with registration by June 8

Second summer session:

\$375 - - paid in full with registration by July 15

Or pay \$78 for each pay-per-lesson

\$720 - - paid in full by June 8

PAY-BY-THE-LESSON and TRIAL LESSONS

Riders who cannot attend lessons on a regular, weekly basis, or who want to take a trial or "brush-up" lesson may enroll and pay by the lesson (\$78 per lesson). The first payment is due with your registration.

PRIVATE AND SEMI-PRIVATE LESSONS

Private and semi-private lessons are ideal for students with their own horses, or for students who want extra personalized help with their riding. Please schedule at least 4 days in advance. One-hour private lessons are \$145 and semi-private lessons are \$100 per person.

HORSEMANSHIP AND RIDING

Horse grooming, tacking up, trail rides, and an occasional unmounted lesson are part of the Woodedge horsemanship and riding experience.

PROPER RIDING ATTIRE

All students enrolled in ANY Woodedge riding program MUST wear a certified ASTM-SEI approved riding helmet.

Long, ankle-length pants or jeans and boots with a textured sole and a 1" heel are also required. Contact the office for guidance.

KINDERIDE

Children up to age seven (or until first grade) are introduced to the basics of riding in the Kinderide program. Weekly half-hour lessons help children gain confidence, improve balance, increase coordination, and develop self-control. Kinderiders are led on ponies or horses trained for lesson use. Lessons are private or in small groups. The session calendar and tuition rates apply.

Riding lessons make a wonderful present at any time of the year. You can purchase gift certificates, Woodedge vests, hats, shirts, sweatshirts, and tote bags at the office.

1.
